2. That the tools developed at Institute of Advanced Studies in Education (IASE), Aizawl, Mizoram will be shared and jointly used by both parties.

3. That the format for Data Entry developed at Institute of Advanced Studies in Education (IASE), Aizawl, Mizoram will be used in uniformity by the two parties. The Institute of Advanced Studies in Education (IASE), Aizawl and Govt. Khawzawl College, Khawzawl in the Data Entry Process.

4. That the data collected by the two parties will be fully restricted to their respective locales.

5. That the Institute of Advanced Studies in Education (IASE), Aizawl, Mizoram will undertake the Analysis and Interpretation of the Research study. The completed Research report will jointly be reviewed by representatives of both parties.

AND WHEREAS THE TERMS OF REFERENCE IS AGREED BY BOTH PARTIES AS FOLLOWS:-

Compilation and Publication Work of the Collaborative Research Project on "Awareness of Covid-19 Pandemic and Community Response to the Challenges Posed: A Comparative Study of Aizawl South City Area and Khawzawl Town" will be undertaken by Institute of Advanced Studies in Education (IASE), Aizawl.

2. The layout and cover design will be decided by representatives of both parties. The number of copies to be printed and published as well as distribution of printed copies will be decided by representatives of both parties as and when the work is fully completed.

3. The expenditure incurred on Printing and Publication will be borne by both parties on equal basis.

4. Both parties will maintain strict confidentiality and prevent disclosure of any information and data exchanged for the undertaking and completion of the Research Study.
