MEMORANDUM OF UNDERSTANDING


The Krishi Vigyan Kendra(KVK) and Govt.Khawzawl College have signed this agreement on the 25th February,2022.

This Memorandum of Understanding is the complete agreement between Government Khawzawl College and Chawngtlai village and maybe amended only by written agreement signed by each of the party involved



- Each party respectively is expected to act in good faith in accordance with this memorandum.


BINDING
