Zero Tolerance Policy of the Institution as per the direction of Statutory Regulatory Authority like UGC

In pursuance of UGC direction on Prevention, Prohibition and redressal of sexual harassment of women employees and students in Higher Educational Institutes in India published in Indian Gazette dated 2nd May, 2016, Govt. Khawzawl College takes a firm stand and nurtures zero tolerance policy towards any form of sexual harassment of the women employees and students of the institution. The members of the Internal Complaint Committee (Prevention of Sexual Harassment of Women at Workplace) closely monitor to identify any form of sexual misconduct & take appropriate action. Grievance Redressal Cell & Gender Sensitization Cell, constituted by IQAC also work in unison to prevent every form of sexual harassment. If any such case happens, the institution at the discretion of Principal initiates all forms of legal & disciplinary actions against the perpetrator. The students are also encouraged to report any matter of sexual misbehavior to Internal Complaint Committee & Grievance Redressal Cell. Gender Sensitization Cell of the institution is very active and apart from holding talks & events on women empowerment, it also make the female students aware of the laws related to women in India & POCSO act. Gender Sensitization Cell of Govt. Khawzawl College has also organized events & workshops to sensitize the women employees & the students about their rights & legal opportunities available for them in case of reported sexual offenses as indicated in SAKSHAM Report (Measures for Ensuring the Safety of Women & Programmes for Gender Sensitization on Campuses).

The institution also takes Zero Tolerance Policy towards any form of ragging in the campus. The booklet "Information Education Communication(IEC): Guidelines for Councils, Universities & Colleges" related to Anti-ragging has been circulated among the students to make them aware of the consequences of ragging in the campus and the institution's firm stand on that. Anti-ragging Cell actively functions to abolish any form of ragging in the campus.

Due to close monitoring, effective sensitization and zero tolerance policy of the institution, any untoward incident like sexual harassment of the women employees and female students has not taken place and any case of ragging has not also been reported.
